#### **Data Collected:**

- Log Files: As part of the service provision process certain information is automatically gathered and stored in log files. This information may include internet protocol (IP)

addresses, browser type, internet service provider (ISP), operating system, date/time stamp, and/or clickstream data.

# **Data Collected via Cookies and Tracking tools**

We and our third party service providers use tracking tools, to collect information about customer(s), customer device(s), and customer use of the Services, like cookies, clear gifs, web beacons/web bugs and other technological methods. Through these tools the information collected may include computer/device operating system type, IP address, browser type/language, mobile device ID, device hardware type, the website or application visited/used, the parts of the Service accessed, the time spent on a page or feature. These Tracking Tools help us learn more about our users and analyse how users use the Service, such as how often users visit our Service, what features they use, what pages they visit, what emails they open, and what other sites or applications they used prior to and after visiting the Service.

# **Web Analytics Service**

RDS may use web analytics services to improve the usability and design of our customer experience. These services may record anonymous mouse clicks, mouse movements, and scrolling activity, but we will never use them to collect personally identifiable information from you. We only use this data internally to help us understand and enhance your RDS experience.

### **Data Security**

RDS adopts technical measures to secure your personal data and strives to implement reasonable, commercially acceptable security procedures and practices appropriate to the nature of the information stored. However, please be aware that no method of transmission over the internet, or method of electronic storage is 100% secure and is vulnerable to interception and thus we are unable to guarantee the absolute security of the Personal Information we have collected.

RDS may share your Personal Information and Virtual Drive Data with law enforcement agencies in accordance with the relevant laws of the Government of Pakistan. RDS may also share data as part of a legal obligation, to comply with regulatory requirements, to protect the safety of users and to protect against legal liability.
